

# Visa Information

Think Pacific expeditions are categorized as **TOURISM** by the Fijian Immigration Department.

Your visit is protected under the Travel & Tourism Regulation in the UK with Think Pacific assigned as your Tour Organizer.

When you land into Fiji you will be asked to complete the Arrivals Card opposite >>>

When asked for your 'Address in Fiji' State **'SMUGGLERS COVE RESORT'** This is often the first stop on the itinerary

When asked to state your 'Occupation'. Please write **'STUDENT'**

When asked to state your 'reason for visiting Fiji'. Please select **'HOLIDAY'**

The Tourist Visa is Free and lasts for 4 months

Please note - You are not classed as undertaking 'employment' or 'working' in Fiji and If you state this, you could be denied entry.

## TRANSIT VISA?

Check for any visas required for countries you may visit on route ('in transit') to Fiji. For example:
